You are further advised to note the following:-

1. Number plates for vehicles which are not in use must be surrendered to the nearest URA Licensing Office. Licence fees continue to be payable for vehicles whose number plates are not surrendered.
2. There are people who call themselves brokers for motor vehicle licences and drivers permits. Tax payers are cautioned against such people as they have been found to defraud unsuspecting taxpayers. URA does not have authorised agents/brokers for this purpose. Taxpayers are advised to deal with URA **DIRECTLY** and avoid third parties.
3. Tax payer Identification Numbers (**TINS**) are issued within 24 hours at **NO COST** to the applicant.
4. Renewal Services are also rendered expeditiously at the DFCU Bank, Impala House Branch, Kimathi Avenue.
